OASIS SB is a multiple award, Indefinite Delivery/Indefinite Quantity (IDIQ) contract that provides a reliable and efficient way to obtain best-value solutions for complex professional services, including: Program Management, Management Consulting, Engineering, Scientific, Logistics, and Financial Management Services.

The benefits of the OASIS SB contract include:

- Spans many areas of expertise and can combine requirements across mission spaces and multiple professional services disciplines;
- Provides support for Commercial and Non-Commercial requirements;
- Allows for flexibility for all contract types, including hybrids and cost-reimbursement, at the task order level; and
- Allows ancillary support components, commonly referred to as Other Direct Costs (ODC), at the task order level.

Utilize the Direct-Award option available through OASIS SB to streamline your procurement process and save valuable time and acquisition dollars while meeting a key socio-economic contracting goal. On OASIS SB, direct awards can be made to Woman-Owned Small Businesses up to \$4 million in total contract value as established in FAR Part 19. Please follow specific FAR and Agency guidance in making direct awards (direct award statute FAR 16.500(b) and 6.302-5(b)). To issue a Socio-Economic category that is going to be a Direct Award (issued on a sole-source basis) reference the OASIS Web Library (https://www.gsa.gov/portal/content/178211) and the Task Order Solicitation Template for justification language and definitions.
